## 1. Liberty Mutual Prize 2008

With the support of Liberty Mutual, the IEA has engaged consultants to review the goals and redefine this prestigious award. A Press Release has now been circulated to all Federated Societies by the Secretary General outlining the new criteria for this top IEA award for 2008. A copy of this Release is attached as an Appendix to this Newsletter. We seek your direct response in promoting this award to the scientific community in your country and region as we are keen to receive many nominations this year. Note the closing date is May 31<sup>st</sup> 2008. The winner of the prize will now to receive \$10,000, which is a significant gesture from Liberty Mutual to encourage ergonomics research. Details of the criteria for the prize can be found on the IEA website under Awards.

You should consider creating your own news release in your Society Newsletter with a specific call for nominations. You may also use local media connections and contacts with Journal editors in your country.

#### 2. Nomination for IEA Fellows

The call for fellow nominations has been added to the IEA website. The deadline for nomination is May 1<sup>st</sup>. This prestigious award recognizes outstanding contributions of a person to ergonomics/human factors at an international level. Please note that an international contribution can be achieved in different ways: through international actions, for example by contributing to the advancement of the discipline, or through regional actions, for example by developing the discipline in a new part of the world.

# 3. EOUID update

We are grateful for the leadership that has been provided by Dr Ralph Bruder (Germany) and Dr Michel Nael (France) to continue the project in developing an IEA template on the ergonomic design process. ## 4. International Occupational Hygienists Congress, Taiwan, 2008

# INTERNATIONAL ERGONOMICS ASSOCIATION ANNOUNCES REQUEST FOR ENTRIES FOR THE IEA/LIBERTY MUTUAL MEDAL

**MADISON, WI, January 29, 2008** – The International Ergonomics Association (IEA) announced today that entries for the IEA/Liberty Mutual Medal would be accepted beginning immediately, with a deadline of May 31, 2008. The IEA/Liberty Mutual Medal recognizes outstanding original research leading to the reduction of work-related injuries and/or to the advancement of theory, understanding, and development of occupational safety research. In a 2005 report, the International Labor Organization estimates that the global workforce of 2.8 billion persons suffers some 270 million serious non-fatal injuries annually.<sup>1</sup>

The IEA/Liberty Mutual Medal carries significant recognition, with one application being selected worldwide. The medal has been restructured in 2008, replacing the previous IEA/Liberty Mutual Prize and IEA/Liberty Mutual Medal. The new Medal will be awarded annually to the author of an original paper that meets criteria for innovation and impact. This is the most prestigious award of its kind in the field of occupational ergonomics and safety and it carries a stipend of \$10,000. The winner's work will be presented at the IEA's Council meeting being held this summer in Reykjavík, Iceland.

Participants must submit a letter of application detailing a summary of the research methodology and the anticipated contribution to occupational safety together with a research paper that meets the following criteria:

- Original work, containing non-proprietary data, describing laboratory, field, or intervention research
- Be unpublished at the time of submission (submitted for publication is allowed)
- Be thirty pages or less, single-spaced using point size 12 with 1 inch margins

Papers should describe the aims of the research, the study methodology, results and discuss its implications for risk reduction. Additionally, it should indicate the contributions of the research to theory, i.e., how the work has advanced the understanding of the causes of accidents and/or ability to mitigate occupational injuries or disability

Applications will be accepted after today. The deadline for all submissions is May 31, 2008. An international review committee, established by the IEA, will select the winning
