Nominations for the IEA/Liberty Mutual Medal in Occupational Safety and Ergonomics are now open. The award recognizes outstanding original research leading to the reduction or mitigation of work-related injuries and/or to the advancement of theory, understanding, and development of occupational safety research. This medal comes with a \$10,000 USD award and is the most coveted award in our profession. Our Council discussion in Bruges uncovered several issues in promoting this award and we are instituting changes for 2011. First, the criteria for research papers have been expanded to include published papers. We will be working more closely with editors to get their nominations for articles published in prestigious journals. Second, federated societies are encouraged to nominate their members. Third, we will be identifying ways to promote the winning papers through different venues, publications, and the website.

IEA Future of Ergonomics Committee

The IEA Governance Committee report that we heard in Bruges raised several important questions and discussions. As a direct result of this committee's work, we have commissioned a special Future of Ergonomics Committee (FEC) to examine the broader question about the future of our profession. This will be done under Ralph Bruder's Promotion and Development Standing Committee. The goal of FEC is to formulate a proposed strategy (or some alternative strategies) for the ergonomics discipline in general and for the IEA in particular to safeguard the success of ergonomics in the future. They have established an ambitious schedule and will report back to Council at our meeting in South Africa and plan to have an IEA Position Paper on the "Future of Ergonomics" at IEA 2012 in Brazil.

This will be one of the most important strategic efforts. We have asked members first from our mature societies to participate in an initial discussion and will expand this as we move further in the assessment process. Jan Dul (Chair, Netherlands) ably leads the FEC and the committee members include: Ralph Bruder (Germany), Peter Buckle (UK), Pascale Carayon (USA), Pierre Falzon (France), Bill Marras (USA), John Wilson (UK), and Bas van der Doelen (Secretary, Netherlands). We are fortunate to have such a skilled group of willing professionals to take on this task. Their ideas will serve as impetus for participation from all of us.

Lighthouse Project in Nicaragua

Barbara Silverstein has just returned from Nicaragua where they tested the ergonomic coffee bean harvesting bag. Kate Stewart, Stephen Bao, Steve Russell, and Barbara Silverstein from Washington State worked with harvest workers from two coffee co-ops to test the impact of an old versus a prototype bag on muscle load, comfort, acceptance and productivity. The initial sense is that this is an improvement but all the data (questionnaire and electromyography) have yet to be analyzed. As with most participatory approaches, the workers had lots of suggestions about how the bags could be improved further. This project is being sponsored by the IEA, the special fund set up by the Japanese Ergonomics Society and 4C. Depending on results, 4C will be in a position to spread the word throughout the region and IEA throughout the coffee producing world. A full

PPCOE in Kaohsiung, Taiwan

The 9th Pan-Pacific Conference on Ergonomics was held from November 7-10 in Taiwan. This marks the 20th anniversary year for a group of leaders with a clear vision and an appreciation for regional research in ergonomic issues. Congratulations to Conference Chairs Chiuhsiang Joe Lin and Eric Min-yang Wang and Honorary Chair Masaharu Kumashiro for a successful conference. Together, with the Ergonomics Society of Taiwan and the Pan-Pacific Council on Ergonomics, they put on a great event. I was lucky enough to attend the conference and witness the celebration of this landmark year. I am grateful for receiving Professor Rungtai Lin's award-winning Eternity Cup, which was a subject of his keynote address, as a gift from this event.

The conference theme – Ergonomics for All – coincides with an important milestone in the evolution of this society. The focus of the conference shifted from occupational ergonomics (Pan-Pacific Conference on Occupational Ergonomics) to a more global theme (Pan-Pacific Conference on Ergonomics). Ergonomics Society of Nigeria Workshop

Samson Adaramola, President of the ESN, reported on the success of the 2nd Annual Ergonomics National Strategic Workshop in Port Harcourt, Nigeria 9-10 December. The theme of the workshop – ergonomic solutions to workplace challenges in Nigeria – was well received by the 36 attendees. Twenty-two of those attending are new inductees to the ESN. In addition to creating an awareness of ergonomics and its potential contribution to Nigerian economic development, the workshop called for legislation and national policies on ergonomics, provisions for the physically challenged, and ergonomic criteria for goods imported into the country. To advance ergonomics professionalism and improve productivity and quality, the workshop addressed the need for criteria for determining National Productivity Order Merit Awards for the country. The event was covered in a local newspaper in Port Harcourt. Though we tried, we were unable to send an IEA representative to this landmark event. I did, however, send a video greeting and congratulations to the participants of the workshop. Congratulations to the Ergonomics Society of Nigeria on a successful event!

First SEANES Conference

The Southeast Asian Network of Ergonomics Societies (SEANES) and the Philippine Ergonomics Society (PHILERGO) hosted the first SEANES conference on December 14 – 17 in Cebu City, Philippines. The theme of the conference – linking ergonomics and organizational strategy – was appropriate for the economic and contemporary issues facing many of the countries in the region. I was impressed how rapidly industrial development was spreading through the region and how these developments accelerated the need for ergonomics in improving human well-being and system performance. Many of the papers presented at the meeting address problems in a way that is relevant to the social context. For example, the strong emphasis for designing public spaces for the elderly was an important variable; one that has much more meaning in a regional context and is highly relevant to system success. Congratulations to Rose Seva, SEANES President, and conference Co-chairs Alma Maria Jenifer Gutierrez and Aura Matias, both from the Philippine Ergonomics Society, for a successful and delightful conference. It was a great pleasure to be with you and witness the first SEANES conference. It was a lot of work and their pioneering spirit led to the success.

At the council meeting, it was decided that the 2nd SEANES Conference will be held in Langkawi, Malaysia, November 14-17 2011. The theme of the conference is Ergonomics: Connecting People and Innovations for Sustainability. Halimahtun Khalid, the new SEANES President, will be organizing this conference and has already begun forming the International Scientific Committee. This promises to be another successful event.

SH@W is a new journal developed in Korea under the leadership of their Occupational Health and Safety Research Institute. Director General Seong-Kyu Kang has been interested in promoting ergonomics in the journal.
