3. Another Honor for our Past IEA President Waldemar Karwowski

4. Certification of ergonomists in Japan

Congratulations to the Japan Ergonomics Society (JES) for the endorsement of their excellent certification system by the IEA Executive Committee at our May meeting. The JES has been developing their certification system based on the IEA Certification requirements as well as the other main certification systems in the USA and Europe.

Their work has highlighted a range of improvements that could be made to the IEA processes. These will be considered later in 2007/08 with an international review of certification requirements for ergonomists.

5. Visits to Federated Societies

During May I have had the pleasure to meet with the Presidents and Board members of Federated Ergonomics Societies in;

- **UK** The Ergonomics Society in Loughborough provided an excellent overview of their range of activities. This includes their work towards professional recognition by applying for a Royal Charter from the Privy Council in the UK. The diverse range of programs and services under Roger Haslam and Anne Ferguson reflects the maturity of a large dynamic Society.
- **Turkey** The future opportunities for the Society in Turkey were discussed with Prof Ozok whom we thank for his leadership in the establishment and development of the Ergonomics Society in Turkey over the last 17 years.
- Sweden and the Nordic Ergonomics Society The cooperation with the Nordic countries to work together in a range of exciting projects provide a great model for us to consider in other regions. The Nordic Ergonomics Society has actively promoted a range of innovative projects under the dynamic leadership of Christina Jonsson. What about trialling the workshop idea from Finland of walking together through a forest or another lovely area to discuss informally as an alternative professional development program format to working in a stuffy seminar room?
- Denmark The Danish Ergonomics Society reflects the broader interests in the working environment and brings together a range of technical skills in projects within Denmark as well as their leading role in NES. Their President, Inger-Marie Wiegman, and Board members have an extensive program of professional development initiatives. Their innovative ideas to encourage greater participation and discussions amongst the participants at the IEA 2009 Congress were appreciated and acknowledged.

6. Meeting with the International Standards Organization (ISO)

I had the opportunity to meet with the ISO in Geneva in May to discuss opportunities for the IEA to work more closely in relation to the development and dissemination of International Standards relating to ergonomics and human factors. Whilst the major focus on ergonomics is with the ISO 159 committee and its four Sub Committees, there are a range of other international Standards relating to ergonomics and human factors. Many IEA members are representing our domain on these committees and we wish to acknowledge their work and

promote these Standards. As such, the IEA TC on Standards will be dropped to enable specific TCs to look into the standards of their respective domain.

My discussions were with the Editor of ISO 159, Stephen Kennedy, and the new Chair of ISO 159, Georg Kramer. We have agreed to explore how the IEA may be able to provide details of all the ISO Standards on the IEA website that include participation of ergonomists in the development of the Standard. This will enable users of the website to easily see those Standards that are relevant to our domain.

We are also exploring opportunities for sessions at the IEA 2009 Congress in Beijing to discuss the role and development of Standards at a national and international level. Your feedback on interest in this area would be appreciated.

7. World Health Organization meeting

Whilst in Geneva I also discussed a range of joint initiatives between the IEA and the WHO. The WHO has developed a 2006 – 2010 Strategic Plan which includes a range of projects involving ergonomics. These are directly with the IEA in our Industrial Developing countries projects on Ergonomics Checkpoints. The Plan also includes details of University researchers who are registered WHO Collaborating Centres and are involved in undertaking projects relating to ergonomics.

A joint WHO / IEA project under consideration includes an international project on the functional needs of face masks for use in pandemics such as SARS and Avian Influenza. This may also involve working collaboratively at an international level with other relevant professionals such as occupational hygienists. We are also working jointly with the WHO on the application of ergonomics in agriculture in developing countries. An emerging issue relates to the broader issue of Health in Working Life. The UK Government initiative in this area will involve The Ergonomics Society; but the WHO is also interested in broader discussion and participation. This may be another discussion topic for the IEA 2009.Congress.

8. International Labour Organization discussions

Joint discussions are currently underway for the active participation of the ILO in a workshop on Ergonomics Checkpoints in Agriculture to be hosted in Malaysia, November 26-27, 2007. The IEA is indebted to the tremendous work and leadership provided by Dr Kazutaka Kogi from Japan in the development of the Ergonomics Checkpoints. We look forward to the participation of attendees working in agriculture in developing countries to attend this workshop with some financial support from the ILO and the IEA. Following the workshop, the Agriculture Ergonomics in Developing Countries, AEDeC 2007 conference will be held from November 28-29, 2007. For details, visit www.aedec2007.org.

9. Financial Support for specific IEA projects

The IEA Executive regularly receives requests for financial support for a wide range of projects associated with the advancement of ergonomics particularly from developing countries. The example above relating to agriculture is a good one where we would like broader participation if funding could be provided. Another example is a current opportunity to host workshops on ergonomics in the mining industry in Botswana and Columbia. These are aimed at developing local ergonomic expertise to contribute to the advancements in health and safety in this industry sector. We would like to support attendance of ergonomic experts to conduct these workshops as part of the Foundation for Ergonomics commenced this year under Hal Hendrick's leadership. We would also like to support the participation of local and racional ergonomics that have been identified.
